The Commission voted to grant renewal of Membership with the degree listing indicated below.

Items for Progress Report:

- 1. The institution's Self-Study notes the existence of three areas of emphasis (Performance/Production, Design/Technology, History/Dramaturgy/Literature) which are offered within its Bachelor of Arts in Theatre degree (see Self-Study, p. 51). The Self-Study also describes these areas of emphasis as having functioning and identifiable sub-populations in the department (see Self-Study, pp. 63-64). As specific information regarding the requirements for these areas of emphasis was unable to be found in the Self-Study or university catalogue, the institution is asked to provide for each emphasis further information including the purpose, coursework required, competencies expected of students enrolled, relationship of the emphasis to the major, and advising guidelines. The institution may wish to prepare and offer curricular charts in the NAST format for each area of emphasis.
- 2. The Self-Study indicates the need for additional design/technology faculty to alleviate work-load challenges and ensure the delivery of design and technology coursework (see Self-Study, p. 108). In

particular, the theatre unit has identified a need for a faculty position in Sound (see Self-Study, p. 22). The Commission asks the institution to provide an update on its efforts to address these workload challenges and ensure the effective delivery of required coursework.

3. The Commission notes that consideration is being given to the need for additional performance faculty with specialization in voice and movement (see Visitors' Report, p. 12). The Commission asks the institution to study this issue and the adequacy of current faculty resources, and to share the results of this study, including any plans to expand the faculty.

RULES OF PRACTICE AND PROCEDURE

PART II: ARTICLE XIII

DISCLOSURE AND CONFIDENTIALITY

- **Section 1.** NAST provides numerous services that include the publication of policy statements, reports, and surveys. These are available to the public, some for a fee. Upon request, NAST will provide the academic and professional qualifications of the members of its policy and decision-making bodies and its administrative personnel.
- Section 2. Upon request, NAST will make publicly available all information about an institution that is published in NAST literature (see Rules of Practice and Procedure, Part II., Article XI., Section 3.). NAST will also indicate whether or not an institution holds or has held accredited Membership.
- Section 3. NAST will not make publicly available any information supplied by the institution or by representatives of NAST in the course of the accreditation process. This includes Self-Study Reports, Visitors' Reports, and correspondence. While NAST encourages institutions to make publicly available information about their accredited status and to share accreditation materials with individuals and agencies having legitimate claim to information beyond that available to the general public, the Association regards all accreditation materials as the property of the institution. Therefore, release of these materials is either through the institution or by its permission.
- Section 4. NAST will not make publicly available any information provided in third-party comment or an institution's response to third-party comment or any correspondence related to third-party comment. See Rules of Practice and Procedure, Part II., Article IV., Section 1.
- Section 5. Dear Members of the NAST Accreditation Committee,

Please find the University of Pittsburgh Theatre Department's response to the committee's action report dated April 24, 2018. In the action report, it was requested that the department provide further information clarifying the curricular requirements of the 3 emphases (Performance, Design/Tech, and History/Literature/Criticism) and a 4th titled "The First Year Academic Community, Inside the Theatre" noted in the self-study. In working to clarify the curricular requirements of the BA offered, we provided advising documents to the committee that are used to help students navigate the curriculum while focusing on a specific area of interest within theatre. After further discussions with NAST representatives we realized that in describing our program as having separate "emphases" we were misrepresenting our current program and the documents provided made it appear as though we had multiple curricular plans.

The areas of emphasis as described in the self-study are not a prescribed course of study rather a path that students might follow if they have an interest in a specific topic in theatre. The documents provided by the department are not curricular in nature, but are used as advising tools to help students navigate the liberal arts program while focusing on interests they have. All students who graduate with a Major in Theatre Arts follow the same core structure as they take required classes in performance, design/tech, and theatre history, but to help the more focused student, we have labelled a series of paths through the major as "emphases." A student with a design emphasis would have the same requirements as a student with performance emphasis, but the flexibility in the major's electives allows them to take classes within the core curriculum that more closely follows there stated interests. To help illustrate our program, we've laid out the theatre major below, then listed three typical students (performer, lighting designer, and playwright) with the classes they would take following this method.

The same is true for the University initiated First Year Academic Community: Inside the Theatre. This program is designed to help incoming students navigate their transition from high-school to college and is not a curricular

program. The first-year academic communities allow interested students to take up to 3 classes in the first term with the same small group of students. These classes focus on a specific area of study that speaks to their shared

interests and goals. The university offers academic communities in a variety of areas of study, one of which is the "Inside the Theatre" community. The courses taken as part of this community do not culminate in a Minor, Certificate, or Major but may be used as part of the university's general education requirements and/or towards a Major or Minor in theatre if the student chooses to pursue them.

We hope this helps clarify the use of the term "emphasis" within our NAST documents, and apologize for the confusion surrounding our use of the term. We understand that many other BA programs offer similar paths, but are actually separated out into separate BA degrees (BA in Theatre Performance, BA in Theatre Design, etc.). It is not our intent to confuse the committee or incoming students, but to offer a selection that shows the flexibility students do have within our foundational degree. Thank you for your time and consideration as we work to solve this issue.
